



GUIDELINES FOR INDOOR AND OUTDOOR VISITS

May 24, 2021

GENERAL GUIDELINES FOR ALL INDOOR AND OUTDOOR VISITS:

All visits need to be scheduled in advance and shall be up to 45 minutes in duration.

All visitors will be screened for symptoms of COVID-19 prior to entering premises/building.

Visitors, who present with symptoms associated with COVID-19, are currently quarantining and/or who have had close contact with someone with COVID-19 in the past 14 days will not be permitted to visit.

All visitors will be asked about vaccination status prior to entering the premises/Residence but vaccination status will not affect ability to visit.

All visitors will be asked to sign a visitation waiver prior to each visit.

All visitors must perform proper hand hygiene prior to and following visitation.

All visitors will be escorted to and from their assigned visitation area and will need to inform staff (when not present) once the visit is completed by calling the main number 884-9099 to arrange escort.

Physical contact, such as handholding, is permitted regardless of vaccination status. Both the resident and their visitor must use an alcohol-based hand sanitizer with at least 60% alcohol before and after physical contact. Embracing and hugging is allowed as long as both people wear masks. If the resident is fully vaccinated, they can choose to have close contact, including touch, with their unvaccinated visitor(s) while all parties continue to wear well-fitting masks.

Staff will be periodically observing all visits for the safety and well-being of our residents, staff and other visitors.

Indoor Visitation: In addition to the guidelines listed above the following applies to indoor visits:

Facemasks must be worn for the entire duration of the visit and must fit snugly over nose and mouth/chin.

Social distancing of 3 feet is required if both the resident and visitor are vaccinated.

Social distancing of 6 feet is required if the visitor is unvaccinated.

One visitor is permitted at a time for each indoor visit.

In-apartment visits will be available Monday – Friday from 10 a.m. - 4 p.m. Please note that **ALL** in-apartment visits in will be available to **fully vaccinated visitors only** for the safety and well-being of residents.

The number of in-apartment visits at any given time will be limited to ensure the Residence is able to manage the DOH requirements for visitation and the well-being of others.

Indoor visits in designated visitation areas will be available Monday – Sunday from 10 a.m. - 4 p.m.

OUTDOOR VISITS: The following guidelines apply in addition to the basic visitation guidelines:

Outdoor visits are preferred, even when a resident and visitor are fully vaccinated against COVID-19, weather and logistics permitting.

Masks may be removed during visits when **Residents AND Visitors** are fully vaccinated.

Social distancing of 3 feet is required if both the resident and visitor are vaccinated.

Social distancing of 6 feet is required if the visitor is unvaccinated.
